Investment Objective

Aims to maximise outperformance relative to the benchmark (MSCI All Country World ex-Australia Index with Net Dividends Reinvested (A\$ Hedged)) over rolling seven year periods, by investing predominantly in listed international shares, supplemented by a passive currency overlay.

Investment Strategy

An actively managed Fund predominantly invested in international shares using high conviction managers hedged back to Australian dollars.

To implement this strategy, Morningstar may design portfolios and/or appoint managers to manage the assets of the Fund.

Key Features


Access to numerous specialist international equity managers, ordinarily not available to Australian investors.



Manager Styles

Contrarian: An approach that often includes holding stocks currently out of favour with the market.

Value: An approach that focuses on selecting stocks that are regarded as relatively cheap based on various price measures.

Growth: The focus is on selecting stocks that are regarded as having above average earnings potential.

Passive currency overlay: Managed by Omega with the aim of neutralising the portfolio's currency exposure by closely tracking the currency basket of the benchmark index.

The long term is the only period where fundamental, valuation driven investing works.




We're valuation-driven investors. Anchoring decisions to an investment's fair value — or what it's really worth — can lead to greater potential for returns.
