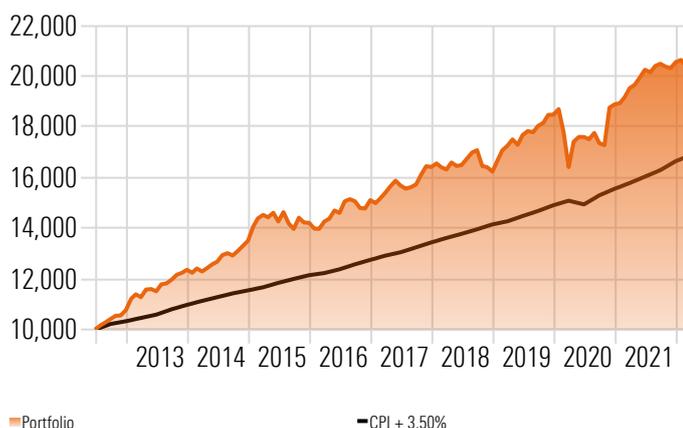

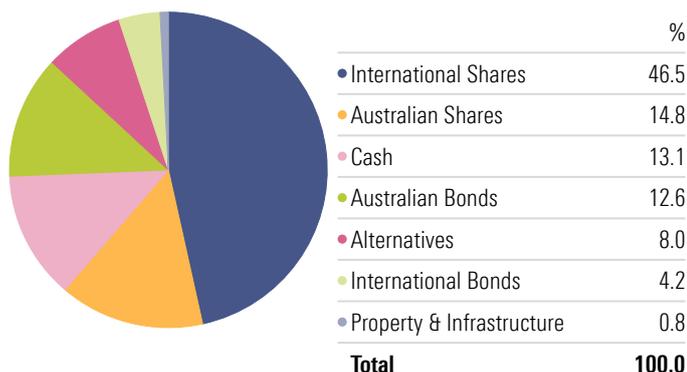

Investment Objective

The Morningstar Growth Portfolio aims to achieve capital growth through investing in a diversified portfolio of growth and defensive asset classes, with an emphasis on growth asset classes. The portfolio aims to earn a rate of return that exceeds inflation by at least 3.5% per annum over rolling 7 year periods.

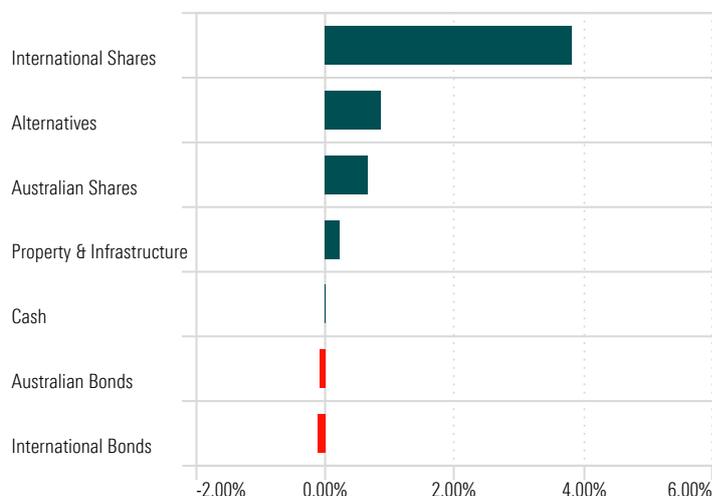
Investment Strategy

An actively managed diversified portfolio of securities across both growth asset classes, such as Australian equities, property and global securities, and defensive oriented asset classes, such as cash and fixed interest securities.

In general, the portfolio's long term average exposure will be around 70% growth assets and around 30% defensive assets, however the allocations will be actively managed within the allowable ranges depending on market conditions.

The portfolio is designed for investors seeking capital growth from a diversified portfolio of growth assets.
