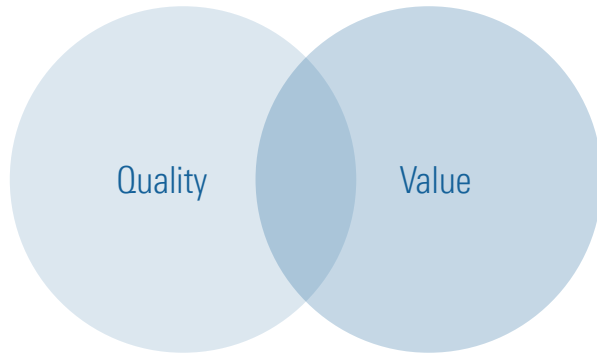

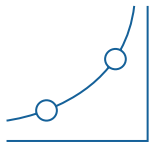


Why invest in the portfolio?

...but it's not just about value. We focus on buying good quality investments at attractive prices looking at characteristics like low debt levels, sustainable earnings, and growing cashflows.

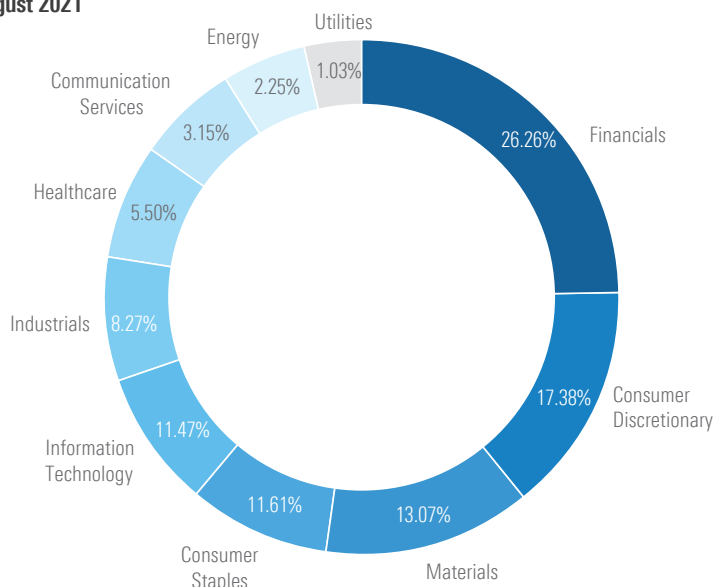


Diversification
