



Investment Objective

The Morningstar Moderate Portfolio aims to achieve a consistent income return and a modest amount of capital growth, by investing in a diversified portfolio of defensive and growth assets, with an emphasis on defensive assets. The portfolio aims to earn a rate of return that exceeds inflation by at least 1% per annum over rolling 3 year periods.


Investment Strategy

An actively managed diversified portfolio of securities across both defensive asset classes, such as cash and fixed interest securities, and growth asset classes such as Australian equities, property and global securities.

In general, the portfolio's long term average exposure will be around 70% defensive assets and around 30% growth assets; however the allocations will be actively managed within the allowable ranges depending on market conditions.

The portfolio is designed for investors seeking a defensive portfolio which provides a consistent income return with potential for some capital growth.

Note: Contribution to return from ETFs has been calculated using NAV returns. Contribution analysis is calculated using a buy and hold methodology.

*Investment performance is before tax and the post-fee return is after the standard management fee of 0.50% and indirect cost ratio (both are inclusive of GST). Investment performance is shown from 01/07/2012 and represents modelled performance only and assumes income received is reinvested. An individual investor's performance will differ from the modelled performance depending on factors such as transaction timing, actual management fees, whether income is paid and any divergence from model portfolio weightings.
