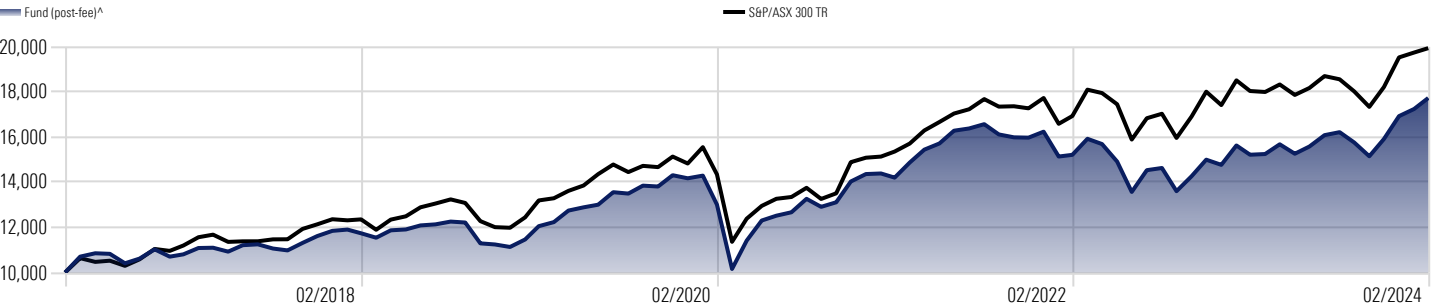

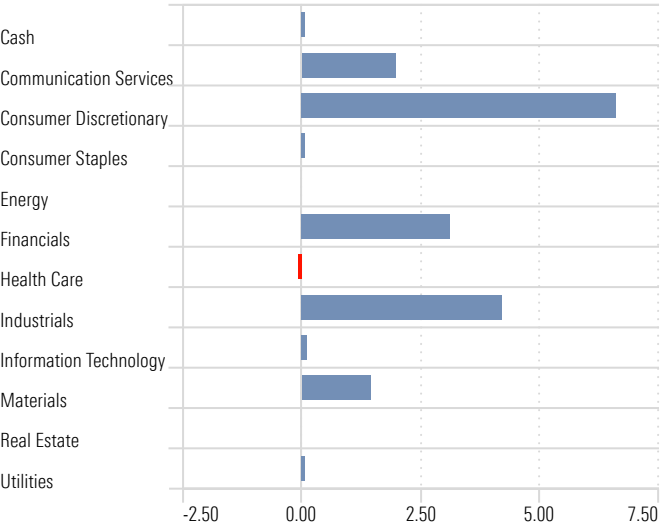

Growth of \$10,000

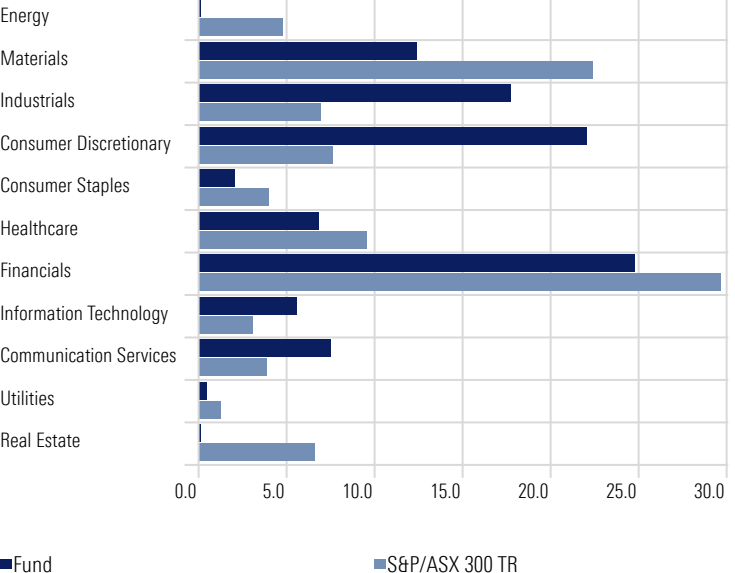


Sector Contribution Over the Year

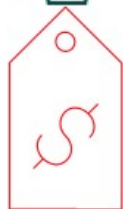
